## **Fall Victim with Puncture Wound Scenario**

Scenario: Your patrol is hiking to Cross Canyon, when the patrol hears a scream coming from up ahead. The patrol sees a male lying at the bottom of the canyon. While the patrol is approaching the victim, you observe that it is an approximate 18 year old male that is conscious. The male had tumbled down the canyon approximately 20 feet. The male is bleeding from an approximate 2" laceration to on the right leg just below the knee. The male states that his lower back hurts and that he did hit his head when he fell and now has a slight headache. The patrol has no cell phone reception. An emergency phone is approximately 10 minutes further up the trail.
