### Skateboard Accident Scenario

Scenario: A 13 year old scout from your troop is skateboarding to the troop's meeting at the **Scout Cabin** at **1 Eagle Way**. Upon approaching the curb, he attempts to jump onto the sidewalk and fails to make the jump. The scout falls and is now screaming in pain. The scout's left leg (half way between the ankle and knee) is swollen and slightly deformed. A scout has his cell phone and calls the local emergency number.

1. Scouts say they have medical gloves on or do have them on.	10

2. The Scout explains what is being done to the victim	5

<b>TREATMENT FOR BROKEN LEG</b>	<b>95 Max pts</b>	XXXXXX
1. Splint in position found.	5	
2. CORRECT SIZE OF SPLINT	XXXXXXX	XXXXXX
a. Splint #1 reaches from the middle of the thigh to past the heel.	5	
b. Splint #2 reaches from the middle of the thigh to past the heel.	5	
3. CORRECT NUMBER OF SPLINTS	XXXXXXX	XXXXXX
a. Splint on the left side of left leg	5	
b. Splint on the right side of the left leg	5	
3. NUMBER OF CRAVATS USED	XXXXXXXXX	XXXXXX
At least 4 Cravats used, located correctly, & ends tucked in	XXXXXXXXX	XXXXXX
a. Cravat #1-located below the break	5	
b. Cravat #1-ends tucked in	5	
c. Cravat #2-located below the break	5

e. Cravat #3-located above the break	5

g. Cravat #4-located above the break	5	
h. Cravat #4-ends tucked in	5	

4. Padding used to fill in voids, if necessary	5	
5. Pulse or capillary refill is checked after splinting. (Patrol Leader may just verbalize that this has been done)	5	
6. Person is asked to wiggle the toes or asked if they can feel the person touching their toes.	5	
7. While splinting, <b>the patrol does not move the leg at all</b>	10	
<b>TREATMENT FOR SHOCK</b>	<b>10 Max pts</b>	<b>XXXXXX</b>
1. Keep the victim warm by covering with a blanket.	10
