As you get closer, you can smell smoke and hear the roar of something burning. As you pass around a bend in the trail you see a 30' dragon taking flight and some brush on fire. You race to put the fire out to save the forest. While fighting the fire, you hear moaning behind a large tree and decide to investigate. When you look behind the tree you find a Knight of the Fleur-de-Lis against the tree.

The knight's name is Sir Tim of Tenderfoot, and he is 25 years old. The knight has no allergies to medications. The knight has removed his armor from his right arm, and you find burns to his right arm from the hand to the elbow, which is blistering. The knight also has a small laceration above his left eyebrow, which though is not deep, it is bleeding and running into his eye. The knight has an abrasion that covers about 2" by 2" to his left lower leg because of the dragon's tooth scrapping his leg.
