The purpose of the First Aid Meet is to test patrol skills and the ability of the patrol to respond as a team to emergency situations.

In an effort to have more consistency in judging and more realistic scenarios, please note the changes from previous meets:

#### Victim Info

#### Reminder - Victims Needed.

Troops are asked to have at least one person per patrol to act as victims for scenarios. This will allow the Boy Scouts to participate in all scenarios. Webelos will also be allowed to act as victims this year.

Victims will report to registration for assignment and instructions. Webelos will remain with the troop they are associated with.

#### **Patrol sizes**

**Reminder** – Each patrol is to have at least **4** Scouts, but not more than **8**. Patrols may NOT change Scouts once the event has started.

#### Patrol Names (NEW!!!)

**Reminder** – Patrol names shall be appropriate to scouting and can not be changed after registration is completed.

#### Judging

Scenario judging and test questions will be based on skills covered in the First Aid section of the Scout Handbook and the First Aid Merit Badge Pamphlet.

Scouts will also be evaluated on their ability to perform as a team in providing correct first aid to an injured person.

#### **Awards**

Each scout will receive a participation patch.

Recognition Awards will be given to the top 5 patrols with the highest scores.

#### Uniforms

Class A uniforms are recommended.

#### **Supplies To Bring**

(NEW!!!)

Blankets to be used as a floor covering and in problems, neckerchiefs or triangular bandages, gauze pads, roller bandages, empty water container (to simulate cleaning of wounds), splints to be made of newspapers, magazines, thin boards, heavy cardboard or commercially made splints.

#### REFERENCE BOOKS & STRETCHERS ARE NOT PERMITTED.

### Room Set Up

**Reminder** – Both the banquet room and engine bay may be used. (The engine bay is not heated, so be sure the Scouts dress appropriately.)

#### Volunteers Needed

Volunteers are needed to:

- Act as victims (Leaders/Parents/Venturers/Webelos)
- Judge (qualified persons only please... see note below)
- Assist with tabulating scores

Judges and victims will register at the registration table for assignment and placement.

Ask them to contact the event chairman & add their names to your registration.
